Check in

MOTION: Elizabeth moves to ratify the December Board minutes that were approved via email. PASSED unanimously.

**Staff reports:** Appended at the end of the minutes. Discussion about using a fire pit for RE led to the decision to seek more information about the type of use desired, fire regulations and insurance as well as how the condo board would view such a request.

**Liaison reports:** The Music committee is planning a mini concert for mid February.

The Worship committee is feeling quite stretched due to various personal issues.

The Communications committee is working to resolve issues that have arisen while Zooming.

The Membership committee has worked with the office administrator to update the membership list. People are indicated as active or inactive. Elise is working with Randi Marten to make a phone tree calling list.

Treasurers report: Pledges are being paid well as people prepare to file tax reports.

The mortgage account has accumulated another \$7500.00. The mortgage balance is currently \$45,442.00. The AGAPE fund is being revised to make it easier for the minister to access it in an emergency situation.

MOTION: Mary Alice moves that the \$50,000.00 bequest from Carolyn Hurdis be moved from an operating fund to a special Board designated restricted fund. PASSED unanimously.

The Finance committee recommended that the Board appoint a task force to determine how this fund would be used. It was agreed that Elise would contact people to serve in this capacity.

MOTION: Elizabeth moves not to accept a donation of \$500.00 that would be restricted for an elevator fund. PASSED: 6 yes, 1 abstention

MOTION: Elizabeth moves to accept a donation of \$1000.00 that will be added to the budget line for the purchase of technology. PASSED Unanimously.

#### **New Business:**

**Finance Committee Presentation:** Jeff Berry spoke about how our pledging income has decreased over the past 5 years. The demographics of an aging congregation indicate that this decline is likely to continue so the committee recommends that the board develop a three-year (2021-2024) strategic plan to address financial issues and goals. A print copy of the proposal is on file with the clerk.

**February Worship Services:** Rev. Denis is experimenting with 2 services; one in person at 10:00 and one on Zoom at 11:15 to be followed by a virtual sermon reflection time at noon. The Worship committee does not plan to do two services when they do their monthly lay service.

**Stewardship:** The pledge campaign theme will be Show Your Love for UUCSC. The campaign will kick off with the February 13th service. Every active member will receive a pledge packet. Our goal is to get \$200,000.00 in pledges. The campaign plans to be complete by mid March.

**Committee on Ministry:** The 4 new members of this committee met virtually with Charlie Donnelly (Board liaison) and Rev. Denis. Their job description will be broadened to serve as a resource for the minister, rather than as a defensive support.

**Fundraising:** In April, after the Pledging Campaign is completed, the Board is planning to have an auction that will incorporate Dining for \$\$. Trish and Elizabeth have offered to work on this but a chairperson and other volunteers are still needed.

# Minister's Report to the Board of Trustees UU Congregation of South County Rev. Denis Letourneau Paul

January 15, 2022

Dear Members of the Board of Trustees,

I have been using this format for my board reports for over ten years now. It has worked well for me, and apparently the boards and congregations I've served. If there is some other format you would like to use, or if you feel anything is missing please let me know.

It's been a super-busy few weeks since I started, and I get the feeling I've been doing just about all of what I should be doing because at the Coordinating Council Meeting this week, everything that came up was something I was already aware of. Whew!

### January Worship

Due to Covid (Oh, how I've come to hate that expression) all services for January are happening online only. We've been following the Zoom services with "coffee hours" that are functioning a lot like "sermon reflections," with an encouraging amount of deep sharing and listening, related to the topic of the sermon. In order to encourage more engagement and address the shifting needs of the congregation, the worship committee would like your approval to offer two services for the first three Sundays in February:

We would like to offer a 10 AM service in person, in the sanctuary AND another service at 11:15 (or so) via Zoom. For the online service, I'd like to facilitate from the sanctuary and follow it with a coffee hour/sermon reflection at a fixed time, open to everyone, regardless of which service they attended. These services will take more

effort than one, and should obviate the need for recorded services on YouTube, so I plan on not doing them for those three services.

- Conversations with two local UCC ministers to talk about the South County Interfaith Clergy Association. (Meetings have been sporadic, but we planned one for 1/19/22 with introducing me as the reason for gathering.)
- I've been posting weekly facebook videos on Friday as "teasers" or invitations to come to the service. (Each week, I've gotten several "shares" and at least a couple messages from folks saying they plan to go but wouldn't have if they hadn't seen the video. So that seems to be working!)

### **Small Group Engagement**

As I meet with congregants there is one sentiment I hear repeatedly and consistently above all others: "We need more opportunities in our congregation to engage with small groups." I mentioned to the Coordinating Council (which I'm thinking of as "The Sisterhood of Getting It Done) that I was hoping to hear more about the various affinity groups, small group ministries, covenant groups, interest groups, and recurring events geared toward sections of the congregation. They expressed their support in helping to gather a group of stakeholders, people interested in and active with the topic.

My hope is to identify the different groups meeting, their history, what they call themselves and how that has evolved, their goals, expectations, and especially their openness to new participants, so that we can have a common understanding and shared language. It's also important that all of this information be communicated to the

larger congregation, as we explore new and varied ways of gathering in the midst of the pandemic — and beyond.

Ultimately, I think our goal as a congregation should be for small groups to deepen engagement, welcome and ensconce newcomers, and serve the long-term health and vibrancy of the congregation. All while continuing to serve the needs that current groups are meeting.
