# Minister's Report to the Board of Directors UU Congregation of South County Rev. Denis Paul

January 31, 2024

Dear Members of the Board of Directors.

Since my last report, I've led the following services: 1/7/24 "The Universal Community," with Sue Strakosch 1/14/24 "The Fondness Factor," with Elizabeth Donovan

Following are my thoughts on the three areas of ministry:

#### Worship Life

UUCSC is being blessed by the presence of really great guest ministers and speakers this winter. Sandra Laub brought her incredible show "Picking Up Stones" to the wider community then spoke to our congregation the next day. Reggie Gibson from RI Black Storytellers (RIBS) delivered a timely, personal, and very UU sermon. On 2/4 I will be doing a pulpit exchange with Rev. Eric Cherry from Westminster, and two weeks later, Rev. Carie Johnson, a UU Chaplain in RI, will preach. What a gift to have such high quality people filling out worship!

During January, a few members of Worship and Music committees and I got to attend a workshop on music in services, presented by the Ballou Channing chapter of the UU Ministers Association. Even though I was one of the planners, it wasn't quite what I expected: more about music as liturgy and less about the mechanics of leading music. We all got a chance to think a bit more expansively about creating an immersive experience.

February is Black History Month and our theme is equity and justice, then March is Women's History Month and our theme is transformation. Both themes relate to the seven words that make up the proposed Article 2.

# Congregational Life

We have a big personnel challenge upon us, and that is finding a replacement for Sue Rogala, who informed us she will be leaving soon. A big part of the challenge, as I work with folks from finance and personnel, will be to provide a clear job title and job description.

On Saturday 2/3 we will have a congregational meeting, an informal conversation in the sanctuary that will hopefully further define the roadmap the board and other committees can use to live into our mission more deeply toward our hopes and goals for the future. These conversations, along with things like the shared read of The Light We Carry by Michelle Obama are really helping to connect leadership with the congregation, further deepening relationships of trust.

In March, in response to direct and indirect requests, I will be starting a regular once a month meditation circle on Wednesday afternoons in the sanctuary, focusing on four different inns of meditation: naming, knowing, listening and loving as articulated by Rev. Erik Walker Wikstrom, former director of worship resources for the UUA.

#### Community Life

We've been hosting so many events open to the public in the last few weeks, between "Picking Up Stones," RIBS and the Sine Nomine concert, that we feel more connected than we've ever been. It's also been wonderful to go to community events like FundaFest and the Washington County Service Fair and interact with some of our members.

In the coming months, we'll be in conversation with Westminster UU about Article 2 in preparation for General Assembly (GA). Dates are forthcoming. I have also reached out to RI Elder Info about doing a seminar for UUCSC and members of the Community on preparing for the end of life. It's a tough subject, but one that comes up frequently as we all seek accompaniment facing the inevitable.

making party on Feb. 25th. Come down after service to make a giant "bead" for our art installation for the month of March with the theme "transformation"

Each month I've been pulling out the exercises, videos and articles that I like from the Soul

Matters curriculum and adding them to my section of the newsletter. I also put some question

prompts and exercises up on the bulletin board in the Oneto Room. That bulletin board has

traditionally been a kids space, but I'm expanding it to include all ages. I'd love some feedback

on both avenues of sharing (newsletter and bulletin board) and what else would be helpful to

include there.

I renewed my LREDA membership and also joined some discussion groups for UU religious

educators. I'm looking forward to a renewed connection with colleagues.

I attended a "music in worship" workshop with Matt Meyer, which was very inspiring. I'm on the

lookout for more workshops and classes, so let me know if you come across any.

We're gearing up to start our OWL for K/1st graders with a parent/child orientation on Feb. 25

and the first class on March 3rd. We have 10 kids in that age group in our congregation, and

hopefully they'll all be able to attend.

Some parents have requested that we stream the service downstairs so parents who are

hanging out in the nursery can tune in. We are going to try that this week by joining the service

by zoom and connecting it to a TV. We'll see what happens!
